SECURITY CAMERA AGREEMENT FORM



Purpose of Security Cameras

Security cameras are installed in the kitchen and living room common areas of this Independent Living Home for the following purposes:

- To ensure the safety and security of all residents.
- To protect property and maintain the integrity of the facility.
- To monitor compliance with house rules in shared spaces only.
- To deter violence, theft, property damage, and unsafe behavior.

CAMERA LOCATIONS

- Kitchen
- Living Room/Common Area
- Main entry hallway
- 2nd Floor Hallway
- Fenced-in Yard

NO CAMERAS ARE PLACED IN PRIVATE OR SENSITIVE AREAS, INCLUDING:

- BEDROOMS
- BATHROOMS
- HALLWAYS LEADING DIRECTLY TO BEDROOMS
- ANY AREA WHERE PRIVACY IS LEGALLY EXPECTED

RECORDING INFORMATION

- CAMERAS RECORD 24 HOURS PER DAY.
- VIDEO FOOTAGE MAY BE REVIEWED BY MANAGEMENT FOR SAFETY, INCIDENT INVESTIGATION, OR RULE ENFORCEMENT.
- FOOTAGE IS STORED SECURELY AND MAY BE SHARED ONLY WITH:
- LAW ENFORCEMENT (IF REQUIRED)
- PAROLE/PROBATION OFFICERS (WHEN APPROPRIATE)
- FACILITY MANAGEMENT
- FOOTAGE WILL NOT BE SHARED PUBLICLY OR USED FOR ANY UNAUTHORIZED PURPOSE.

RESIDENT RESPONSIBILITIES

RESIDENTS AGREE TO THE FOLLOWING:

- I WILL NOT TAMPER WITH, DISCONNECT, COVER, BLOCK, DAMAGE, OR INTERFERE WITH ANY SECURITY CAMERA OR ITS WIRING.
- I UNDERSTAND THAT TAMPERING WITH CAMERAS MAY RESULT IN REMOVAL FROM THE PROGRAM.
- I UNDERSTAND CAMERAS ARE FOR SAFETY AND SECURITY, NOT FOR PERSONAL SURVEILLANCE OF INDIVIDUAL RESIDENTS.

ACKNOWLEDGMENT OF UNDERSTANDING



- By signing this agreement, I acknowledge and understand the following:
- Cameras are used in common areas only.
- Cameras are for security purposes and not for monitoring personal conversations.
- I consent to being recorded in shared spaces while residing in the home.
- I understand that refusal to sign this agreement may result in denial of residency.

Tampering Policy Statement: Residents are strictly prohibited from tampering with, covering, disconnecting, damaging, or interfering with any security camera or camera equipment on the premises. Any resident found tampering with security cameras will be subject to immediate eviction from the program without further warning.
